

**Q. No. 9: What documents are required at the time of joining in allotted Medical College?**

**Ans:** Original documents required at the time of joining in allotted Medical/Dental College are as mentioned below:

- i. Admit Card issued by NBE
- ii. Result/Rank Letter issued by NBE
- iii. Mark Sheets of MBBS 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> Professional Examinations.
- iv. MBBS Degree Certificate/Provisional Certificate.
- v. Internship Completion Certificate/Certificate from the Head of Institution or College that the candidate shall complete the Internship by **31<sup>st</sup> March, of the year of admission.**
- vi. Permanent / provisional Registration Certificate issued by MCI /State Medical Counsel. Provision Registration Certificate is acceptable only in cases where candidate is undergoing internship and likely to complete the same on or before **31<sup>st</sup> March of year of admission.**
- vii. High School/Higher Secondary Certificate/Birth Certificate as proof of date of birth.
- viii. Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for AIPGMEE i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
- ix. The Candidate should also bring the following certificates, if applicable
  - a) SC/ST Certificate issued by the **competent authority** (in the format as specified in the prospectus) and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate.
  - b) OBC certificate issued by the **competent authority**. The sub-caste should tally with the Central List of OBC. The OBC candidates **should not belong to Creamy Layer**. The OBC certificate must be in the format as mentioned in the prospectus.
  - c) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act,2016. **No other PwD certificate, issued by any other Authorities/ Hospital will be entertained.** The format of **Certificate of Disability** is attached as ANNEXURE-I.

**Candidates without original certificates / documents shall not be allowed to take admission in allotted Medical College.**

**Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that "their original certificates are deposited with the Institute / College / University" shall not be allowed to take admission in allotted Medical College.**
